# **HOW IT WORKS**

- The customer determines that it needs loss prevention assistance on an employment matter—such as diversity awareness or discrimination training, updating its employment handbook, putting together an affirmative action plan, assessing pay-equity exposure, etc.
- 2. The customer accesses Chubb's on-line directory of more than 120 preapproved vendors.





- 3. The customer selects one or more vendors from the list and makes direct contact to arrange for services. We may allow a customer to use a vendor that is not on our list, as long as we approve that vendor in advance.\*
- 4. Once the services are delivered and an invoice is issued, we reimburse the customer for 50% of the cost of the qualified services, up to 10% of the customer's EPLI premium.
- \* Please note that services rendered by one's own organization are not eligible for reimbursement.
